President's Report

2020. What can be said about such a year? For the Club, the year started out brightly, with additional teams, new recruits, promotion back to Women's Premier League, and lots of enthusiasm.

Then in progressively from March as COVID-19 cases in Melbourne rose, training was cancelled, lockdowns introduced, and the start of the season postponed. With lockdowns then beginning to ease in June, we tentatively began to return to training – initially limited to 'no close contact drills', and just our top squads – ahead of a planned season start in late July (for a condensed season that would run later than normal in the year). But COVID-19 cases rose again, and back into lockdown we all went. Eventually it became clear that a 2020 hockey season wasn't going to be feasible, and HV officially cancelled it.

Introspectively, a big thanks to all those within the Club who worked to try and get a season going — whether that be coaches & managers organising trainings and ensuring compliance with COVIDSafe restrictions, or Committee members liaising with HV, MUS, and SNHC to continually adapt & update plans for returning to hockey (all in vain). As well as everyone's patience, understanding, and cooperation throughout the year in difficult & ever-changing circumstances.

More broadly, and more importantly though, on behalf of the Club I would like to thank all those Shoppers who have contributed to the community response to this pandemic. From frontline medical workers, teachers, and other essential workers, to researchers, academics, and experts advising the community and government (even on the Australian Health Protection Principal Committee for example!). We're fortunate and proud to have so many incredibly talented and dedicated people at our club.

I hope that all of our members & friends, and your friends & family, are in good health and getting through these challenging times okay. We look forward, fingers-crossed, to seeing you back with us at a hockey field or a social function in 2021, once again enjoying our sport, our club, and being with our friends & clubmates.

Treasurer's Report

2020 was obviously a very unusual and difficult year for the club, as we usually count on winter fees for the bulk of our annual income. Conversely, though the season was cancelled, we still incurred substantial expenses in twice preparing for planned season starts. However, thanks to grants from the federal government as well as support from MU Sport (albeit less than in a normal year), we were able to emerge from it without a drastic drop in our overall balance sheet.

Government support

In early 2020 the federal government made funding (a minimum of \$20,000) available to small businesses which had lost 30% or more income as a result of COVID, under the *Boosting Cash Flow for Employers* program. We were able to qualify for this and so by September had received \$15,000 worth of rebates, with another \$5,000 to be paid in October. This money was predominantly used to help meet ongoing commitments related to coaching, as well as to cover ongoing administrative costs.

We did not claim JobKeeper, as we had no eligible employees who did not have another employer claiming JobKeeper for them.

Tax debt

As mentioned at the last AGM, we still had roughly \$6,000 owing to the government for unpaid PAYG and GST payments. These continued to be paid down according to an agreed schedule, and as of March 2020 the debt was completely cleared.

Winter Membership fee payments and associated liability

Before the winter season was cancelled we had around forty members pay their season fees. At the time we offered to refund these for anyone who needed the money back, but otherwise asked that they leave it as a pre-payment for 2021, as we were unsure at the time whether we would have the capital to continue through 2020 without it.

We are grateful that most members agreed to let us hold onto the payments, however it is important to note that this means we can expect slightly lower income from registration this year and may also have to make some repayments if anyone who has already paid is no longer able to play.

The current balance of this liability is \$15,870, which is projected to be about 17% of our expected winter fees.

Registration for GST

2019/20 was the second year in which the club was registered for GST, which proved to be very useful. The majority of our income was from grants, which are GST exempt, while about half our spending contained GST. As a result we were able to claim back just under \$1,000 from the government as part of our quarterly Business Activity Statements. In future the GST collected and paid is more likely to balance fairly evenly, as in 2018/2019.

Profit/Loss

Overall we had an on-paper loss of around \$18,000 during the 2019/2020 season. However, this includes over \$7,000 spent on uniforms which were then not sold as a result of COVID, meaning

these are an asset that should be able to be monetised in 2021. This, combined with the fact that at the time of the report we were still expecting another government boost of \$5,000 (which we have since received) means that our overall financial position was actually only about \$5,000 worse than at the same time last year.

Given that we lost about \$90,000 of income due to the cancelled season this is an incredibly positive position to find ourselves in.
